COMMUNITY TIME CAPSULE



Individuals, businesses, groups and organizations can purchase a time “caplet” for only \$100

and fill it with their own commemorative items. The Legacy Advisory Board is hosting a fundraising campaign to celebrate 100 years of long term care in Campbell County.



*The sealed plastic time caplets measure 2.7” x 3” x 9.8” in diameter and will be inserted into an air and water tight stainless steel capsule.*

Contents of the caplet will be held for 90 days following opening for descendants or businesses to claim. After

this time, the contents become property of The Legacy or its successor and will be donated as appropriate when opened. Contents may not be flammable, hazardous or perishable and must fit within the individual caplet when closed. The capsule will be buried on Memorial Day, May 28, 2018 at The Legacy Living and Rehabilitation Center. The time capsule will be opened on Memorial Day 2064.
